# Charity Next





#### Introduction

The Whitehall & Industry Group (WIG) is an independent, non-lobbying charity and membership organization founded in 1984. We believe society works better when people in business, government and the not-for-profit sectors learn from each other and collaborate.

In 2010, WIG took over the running of the Charity Next secondment programme, previously established by the Prince's Foundation in 2008. Charity Next gives future leaders of the public sector (Civil Service Fast Streamers) the opportunity to spend six months in a charity, social enterprise, or wider not-for-profit organisation.

Over the course of their placements, the secondees will deliver challenging, objective-driven projects which provide emphatic, long-lasting impact for their hosts.

## Why participate?

#### **For Hosts**

#### **For Secondees**

- Make a real difference through your work and improve the lives and opportunities of some of the most vulnerable groups in society
- Be challenged to demonstrate real leadership and consider the societal impact of your decisions
- · Develop key skills and learn to deploy these in a new setting
  - Secondees develop their capacity to manage people and teams whilst improving their initiative and resourcefulness
- Transfer knowledge back into government to inform and enhance future decisions and policymaking
  - Understanding how different sized organisations operate and implement processes will enable you to bring learning back into government to share with your colleagues
- Build your resilience, understanding and effectiveness in different working environments

### The process and costs

Once we have a confirmation from the Fast Stream regarding which schemes we will be working with in that six month period, we open applications for 5 weeks in both spring and autumn. There are a around 80 placements per year.

Schemes we have worked with include:

- Generalist
- Project Delivery
- Finance
- Digital, Data & Technology
- Science & Engineering
- Statistics
- Commercial



We ask those who would like to apply to send us a proposal for a role. If appropriate,zz we determine which placement they would be most suited for and provide thezz relevant application form to the host organisation.

We then work with organisations to ensure the applications are as strong as they canzz be by reviewing the application and sending back some feedback to improve it forzz submission. When the applications are finished, we submit them to the Fast Streamzz for matching. Once potential matches have been found, we arrange a meetingzz between WIG, the secondee and the host organisation to discuss the role and agreezz the details of the secondment agreement between both parties, which highlightszz best practice and any required workplace adjustments.

WIG charge a brokerage fee for facilitating the secondment. This is payable at the point of the confirmed match.

**WIG fee: £2,500 + VAT** 

The Civil Service continues to pay the secondee's base salary and benefitpackage for the duration of the 6 month secondment. The secondee remains a Fast Stream employee and there is no change to their employment status.
